A completed set of Bidding Documents may be purchased by interested Bidders from the address given below upon submission of a written letter of intent and/or its application for eligibility and latest Class "A" documents, addressed to the BAC Chairman, not later than **10:00 AM of March 07, 2019**. Hard copy of the ITB from G-EPS, Document Request List, and Bid Notice Abstract should be attached to the letter of intent (LOI). Payment of a non-refundable fee for the bidding documents is **Php10,000.00**.

The City Government of Tacloban thru the BAC will hold a Pre-Bid Conference on **February 21, 2019, 10:00 AM** at the BAC Office, Balyuan Livelihood Training Center, Magsaysay Blvd., Tacloban City, which shall be open only to all interested parties who have purchased the Bidding Documents


