Bids received in excess of the ABC shall be automatically rejected at bid opening.

Completion of the works required is **One Hundred Fifty (150)** calendar days. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible bidder is contained in the bidding documents, particularly in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the City Government of Tacloban thru the Bids and Awards Committee (BAC) Secretariat, Balyuan Livelihood Training Center, Magsaysay Blvd., Tacloban City, and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 pm. Mondays to Fridays.

A completed set of Bidding Documents may be purchased by interested Bidders from the address given below upon submission of a written letter of intent and/or its application for eligibility and latest Class "A" documents, addressed to the BAC Chairman, not later than **10:00 AM of March 18, 2019**. Hard copy of the ITB from G-EPS, Document Request List, and Bid Notice Abstract should be attached to the letter of intent (LOI). Payment of a non-refundable fee for the bidding documents is **Php10,000.00**.

The City Government of Tacloban thru the BAC will hold a Pre-Bid Conference on **March 04, 2019, 10:00 AM** at the BAC Office, Balyuan Livelihood Training Center, Magsaysay Blvd., Tacloban City, which shall be open only to all interested parties who have purchased the Bidding Documents


