The City Government of Tacloban thru the **20% Economic Development Fund**, intends to apply the sum of **One Million Five Hundred Eighty-Three Thousand Two Hundred Forty-Nine Pesos & 46/100 (Php1,583,249.46)** only, being the Approved Budget for the Contract (ABC) to payment under the contract for the **ROAD REHABILITATION at Brgy.74, Lower Nula-Tula, Tacloban City**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Completion of the works required is **Sixty (60)** calendar days. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible bidder is contained in the bidding documents, particularly in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the City Government of Tacloban thru the Bids and Awards Committee (BAC) Secretariat, Balyuan Livelihood Training Center, Magsaysay Blvd., Tacloban City, and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 pm. Mondays to Fridays.

A completed set of Bidding Documents may be purchased by interested Bidders from the address given below upon submission of a written letter of intent and/or its application for eligibility and latest Class "A" documents, addressed to the BAC Chairman, not later than **10:00 AM of February 28, 2019**. Hard copy of the ITB from G-EPS, Document Request List, and Bid Notice Abstract should be attached to the letter of intent (LOI). Payment of a non-refundable fee for the bidding documents is **Php5,000.00**.


