The City Government of Tacloban thru the **City Engineer's Office-Current Appropriation**, intends to apply the sum of **Twelve Million Three Hundred Twenty-Four Thousand One Hundred Fifty-Nine Pesos & 84/100 (Php12,324,159.84)** only, being the Approved Budget for the Contract (ABC) to payment under the contract for **FABRICATION/INSTALLATION OF DOORS & WINDOWS at City Hall Old and New Building, Tacloban City**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Completion of the works required is **One Hundred Twenty (120)** calendar days. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible bidder is contained in the bidding documents, particularly in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the City Government of Tacloban thru the Bids and Awards Committee (BAC) Secretariat, BAC Office, Tacloban City Hall, Kanhuraw Hill, Tacloban City, and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 pm. Mondays to Thursdays only. Please note that no bid will be accepted on Fridays.

A completed set of Bidding Documents may be purchased by interested Bidders from the address given below upon submission of a written letter of intent and/or its application for eligibility and latest Class "A" documents, addressed to the BAC Chairman, not later than **2:00 PM of April 28, 2020**. Hard copy of the ITB from G-EPS, Document Request List, and Bid Notice Abstract should be attached to the letter of intent (LOI). Payment of a refundable fee for the bidding documents is **Php25,000.00**.

The City Government of Tacloban thru the BAC will hold a Pre-Bid Conference on **April 14, 2020, 02:00 PM** at the BAC Office, Tacloban City Hall, Kanhuraw Hill, Tacloban City.

Bids must be delivered to the address below on or before **2:00 PM of April 28, 2020**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of Tacloban reserves the right to accept or reject any bid, to annul the bidding process, and to reject bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
