Mondays to Thursdays only. Please note that no bid will be accepted on Fridays.

A completed set of Bidding Documents may be purchased by interested Bidders from the address given below upon submission of a written letter of intent and/or its application for eligibility and latest Class "A" documents, addressed to the BAC Chairman, not later than **2:00 PM of April 14, 2020**. Hard copy of the ITB from G-EPS, Document Request List, and Bid Notice Abstract should be attached to the letter of intent (LOI). Payment of a refundable fee for the bidding documents is **Php10,000.00**.

The City Government of Tacloban thru the BAC will hold a Pre-Bid Conference on **March 31, 2020, 02:00 PM** at the BAC Office, Tacloban City Hall, Kanhuraw Hill, Tacloban City.


Bids must be delivered to the address below on or before **2:00 PM of April 14, 2020**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of Tacloban reserves the right to accept or reject any bid, to annul the bidding process, and to reject bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
