## Contract Agreement

for

### PROCUREMENT OF OFFICE SUPPLIES AND DEVICES

THIS AGREEMENT made on the 25<sup>th</sup> day of March, 2021 between **THE CITY GOVERNMENT OF TACLOBAN** of the Philippines (hereinafter called "the Entity") of the one part and JANNYLYN ENTERPRISES of Tacloban City, Philippines (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods, **Procurement of Office Supplies and Devices**, and has accepted a bid by the Supplier for the supply of the goods in the sum of **One Million One Hundred Thirty-one Thousand One Hundred Forty-seven Pesos & 00/100 (P1,131,147.00) only**, (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a. General and Special Condition of Contract;
  - b. Contract Agreement;
  - c. Winning bidder's bid, including the Technical and Financial Proposals, and all other documents/statements submitted;
  - d. Performance Security;
  - e. NFCC or Credit line in accordance with **ITB** Clause 5.5
  - f. Notice of Award of Contract; and
  - g. Other contract documents that may be required by existing laws.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. The period of delivery of items shall be within Thirty (30) calendar days upon receipt of the Notice to Proceed; however, if the Supplier fails to deliver within the given period, this Agreement shall be automatically terminated and the City need not bring a court action for the rescission of this Contract.
6. That in case of dispute or difference of any kind whatsoever shall arise between the parties in connection with the implementation of Contract, Section 59.2 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act shall govern.
7. Parties, further agree that any dispute arising from the implementation of the contract will be submitted for **ARBITRATION** in Tacloban City **ONLY** AND in accordance with RA 876 otherwise known as "The Arbitration Law".

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
