CONTRACT AGREEMENT

THIS AGREEMENT, is made and entered into this 28th day of December, 2021, in Tacloban City, Philippines, between **THE CITY GOVERNMENT OF TACLOBAN** of the Philippines (hereinafter called "the Entity") of the one part and **LATORRE BUILDERS AND CONSTRUCTION OF DIVERSION RD., CAIBAAN, BRGY. 95, TACLOBAN CITY** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Negotiated Procurement for Consolidated Projects: Construction of Pathways and Covered Canal at Brgy. 110 Utap, Tacloban City and Construction/Rehabilitation, Repair of Drainage System, Drainage Canal and Cover at Brgy. 63 Mangga Sagkahan, Tacloban City**, with POW# 21-024-A (3) and 21-024-B(3) (hereinafter called the "Works"), and the Entity has accepted the Bid **Two Million Three Hundred Twelve Thousand One Hundred Nineteen Pesos & 26/100 (Php2,312,119.26) only**, by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. POW;
 - d. PERT/CPM
 - e. Performance Security;
 - f. Notice of Award of Contract and the Bidder's conforme thereto; and
 - g. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Two Million Three Hundred Twelve Thousand One Hundred Nineteen Pesos & 26/100 (Php2,312,119.26) only**, or such other sums as may be ascertained, **LATORRE BUILDERS AND CONSTRUCTION** agrees to execute and complete the Works and remedy any defects therein in accordance with his/her/its Bid.

4. The City Government of Tacloban agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. That in case of dispute or difference of any kind whatsoever shall arise between the parties in connection with the implementation of Contract, Section 59.2 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act shall govern.
6. Parties, further agree that any dispute arising from the implementation of the contract will be submitted for **ARBITRATION** in Tacloban City **ONLY** AND in accordance with RA 876 otherwise known as "The Arbitration Law".

IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.
